Must receive "satisfactory progress" or "achieved" on all other objectives in PharmAcademic.</li> <li>• Completed all required activities, evaluations, projects, and presentations for residency.</li> <li>• Formal, written manuscript for research project acceptable for journal submission.</li> <li>• Completed electronic e-portfolio of all written projects, presentations, and deliverables.</li> </ul>
